Regulator: Cayman Islands Monetary Authority – Insurance Supervision Division

Companies: Cayman Islands Registrar of Companies

Tax: Cayman Islands Department of International Tax Cooperation

Reporting

Audited financial statements: To be filed with the Cayman Islands Monetary Authority within six months of the fiscal year end of the regulated entity. For certain Class B(iii) and Class D entities quarterly unaudited financial statements may be requested by the Cayman Islands Monetary Authority within 60 days of quarter end as per a licensing condition.

Compiled: Submitted by SRS

Duration: Published timeframe by the Cayman Islands Monetary Authority is 4-6 weeks

KYC: Robust due diligence process on shareholders, ultimate beneficial owners, directors and officers
